For membership, "UK" includes Channel Islands and Isle of Man. "Europe outside the UK" includes the Republic of Ireland and Continental Europe. "Outside Europe" is anywhere else.

Students are individuals aged 25 or under on 1 January; proof of age may be requested.

The membership year is the calendar year; fees are due on 1 January.

Members joining in mid-year pay a full year's fee and are sent the publications already issued in that year.
